Terms and Conditions of the "Dot Challenge 2024" Competition

I. General Provisions

- 1. The organizer of the contest (hereinafter the "Contest") is The Dots Cosmetics Agata Głaba-Buzalska, ul. NIEPOŁOMICKA, 49A, apt. 22, 80-180 Gdańsk, NIP: 6891230011, Regon: 525375506 (hereinafter also referred to as the "Organizer").
- 2. These regulations set out the rules, scope, and conditions for participation in the Dot Challenge 2024 (hereinafter also referred to as the "Regulations").
- 3. The Contest will run from September 17, 2024, to September 23, 2024, until 11:59 PM GMT+2 (hereinafter also referred to as the "Contest Duration").
- 4. The Contest is not created, administered, or sponsored by Instagram.
- 5. The Contest is conducted on www.instagram.com on the @the_dots_cosmetics profile.

II. Conditions for Participating in the Contest

- 1. The Contest is open to individuals who are 18 years or older. A participant in the Contest can only be a person who has an Instagram profile in compliance with Instagram's terms and conditions (hereinafter also referred to as the "Participant").
- 2. Participation in the Contest is only personal, i.e., it is not permissible to create accounts or submit contest entries on behalf of third parties.
- 3. Employees of the Organizer and individuals collaborating with the Organizer in organizing the contest, as well as their immediate family members (i.e., ancestors, descendants, siblings, spouses, parents of spouses, and adopted persons), are not eligible to participate in the Contest.
- 4. Participants agree, in the event of winning a prize or receiving recognition, to have their contest post, name, and/or Instagram username published on the Organizer's Instagram profile.
- 5. The Participant declares that:
 - 1. they are a legal adult with full legal capacity;
 - 2. they have read and voluntarily agree to the terms of these Regulations;
 - 3. they accept the conditions of the Regulations;
 - 4. they agree to comply with the provisions of the Regulations, including Instagram's terms of use;
 - 5. they have consented to the processing of their personal data for purposes related to participation in the Contest;
 - 6. they are a registered user of the Instagram social media platform.

III. Contest Rules and Course

- 1. To enter the contest, you must:
 - 1. Create a makeup look that is a personal interpretation of the contest theme "Dots of Creativity":
 - 2. Post the contest makeup on your Instagram profile and tag @the_dots_cosmetics.
- 2. Contest posts must be published during the Contest Duration, i.e., from September 17, 2024, to September 23, 2024, by 11:59 PM GMT+2.
- 3. Posts published after the deadline specified in point 2 above will not be considered for the Contest.
- 4. Contest entries will be judged by a three-person Contest Committee (hereinafter referred to as the "Committee") consisting of representatives of the Organizer.
- 5. The Committee will award one person (hereinafter also referred to as the "Winner") based on an evaluation of the contest posts, taking into account criteria such as adherence to the theme, originality, creativity, and ingenuity.
- 6. The Committee may grant special awards.
- 7. The Winner will be announced via a post on the Organizer's profile on September 25, 2024, by 8:00 PM.

- 8. The Winner is required to send all necessary information for prize delivery (name and address for the prize) to the email address: kontakt@thedotscosmetics.com within 5 (five) business days of the Contest results being announced.
- 9. Failure to fulfill the information obligations stated in point 10 within the given timeframe will result in the Winner losing the right to the prize.
- 10. The Organizer is not responsible for the inability to deliver the prize to the Winner due to reasons beyond the Organizer's control, especially due to the Winner providing incorrect data or force majeure events.
- 11. In the event of the Winner's resignation or loss of the right to the prize for any reason, the Organizer reserves the right to award the prize to the next Participant selected by the Contest Committee. In this case, the Winner will be informed of their victory via a private message sent through Instagram.
- 12. It is not possible to transfer the right to the prize to third parties.
- 13. It is not possible to receive a cash equivalent of the prize.
- 14. It is not possible to refuse part of the prize. Refusing part of the prize is equivalent to refusing the entire prize.

IV. Contest Supervision

- The Organizer reserves the right to exclude from the Contest Participants whose actions are contrary to the law, good customs, or the Contest Regulations, as well as Instagram's terms of service, particularly Participants who:
 - 1. do not act personally but through third parties;
 - 2. engage in actions using an account/profile created in violation of Instagram's rules;
 - 3. create fake accounts/profiles on Instagram;
 - 4. submit entries containing content that is illegal, inappropriate, infringes on third-party rights, or depicts or describes situations/events that may pose a risk to the health or life of people or animals;
 - whose post has been edited.
- 2. Any detection of dishonest participation in the Contest by a Participant will result in their exclusion from the Contest.

V. Prizes

- 1. The Contest offers a prize a voucher worth 150 PLN (one hundred and fifty zloty) for purchases at the Organizer's online store at https://thedotscosmetics.com/.
- 2. If the Contest Committee awards a Special Prize, the award will be a voucher worth 50 PLN (fifty zloty) for purchases at the Organizer's online store at https://thedotscosmetics.com/.

VI. Personal Data Processing

By posting a contest entry, each Participant acknowledges that the Organizer will process their personal data as part of the Contest. Providing this data is voluntary but necessary for Contest participation. Failure to provide this data will result in the contest entry not being considered. Participants have the right to access their personal data, correct it, request its deletion, limit its processing, or object to its processing.

VII. Final Provisions

- 1. The Regulations are available on the Organizer's website https://thedotscosmetics.com/.
- 2. By entering the Contest, each Participant accepts the conditions of these Regulations.
- 3. In matters not regulated by the Regulations, the provisions of the Civil Code apply.
- 4. The prizes mentioned in §5 are tax-exempt under Article 21, section 1, point 68a of the Polish Personal Income Tax Act of July 26, 1991 (Journal of Laws of 2018, item 2126).
